Success Report: 22 August 2011

The following other convictions were also secured by the Honeydew detective services:

- Constable Gertrude Leshiba secured a sentence for a Business Burglary case. The suspect was found guilty and sentenced to seven (7) years imprisonment.
- Constable Tiny Mabalane secured a sentence for a malicious damage to property case. The suspect was found guilty and sentenced R1000-00 or 3 months imprisonment.
- Constable Stranger Mnkansi secured a sentence for a Possession of dagga case. The suspect was found guilty and fined R2000-00 or 6 months imprisonment.
- Sergeant Andries Mahalefa secured a sentence for a Possession of stolen property case. The suspect was found guilty and fined R4000-00 or 8 months imprisonment.
- Warrant Officer Michael Erasmus secured a sentence for a House Robbery that was committed during 2009. Suspect one was found guilty on charges of House breaking with intent to rob and robbery and sentenced to twenty years imprisonment and declared unfit to possess a firearm. Suspect two was found guilty on charges of House breaking and theft and House breaking with the intent to rob and robbery. He was sentenced to 30 years imprisonment and declared unfit to possess a firearm.
- Warrant Officer Werner Eksteen secured a successful conviction after a suspect was found guilty on a 2003 Murder and Robbery case as follows: Murder – Life imprisonment, Robbery – 15 years imprisonment, Possession of unlicensed firearm and ammunition – 4 years imprisonment.
